**Subject: Launch of efficient transaction processing Application for SEZ & Non SEZ Transactions : IMEXIO**

Dear Sir / Madam,

As you may be aware, with reference to Budget announcement made by Hon. Finance Minister in Budget 2022 presented on 1st Feb 22, SEZ transactions were proposed to be shifted to Custom's National Portal by Sep 2022. Accordingly, DG System, CBIC has been working to develop ICEGATE system to meet the needs of SEZ functioning and pilot runs have been initiated at GIFT IFSC and MEPZ since May 2023. This is expected to support filing of Custom's transactions for merchandise. Ministry of Commerce & Industry and Ministry of Revenue are observing these pilot implementations and look forward to expanding the same to other Zones in a gradual manner. Towards this end ICEGATE has published a file format for preparing and filing SEZ Bill of Entry transaction for processing through ICEGATE, format for other customs transactions are pending to be released. As you are aware, in case of ICEGATE the Units will need to prepare the Import data file in specified format using its ERP system or any other software tools.

As a measure of your continuous support and relationship of over 12 years of filing transactions through SEZ Online System, a facilitation measure is being made available by NDML by launching a new platform "IMEXIO" for preparing Customs transactions in ICEGATE filing format. This system will support preparation and filing of SEZ Bill of Entry as well as domestic BoE for imports from EDI Ports. As and when ICEGATE will introduce other Customs transactions for SEZ Units, the same will be made available in IMEXIO also. The system is designed to provide comprehensive transaction preparation and filing experience. IMEXIO can be accessed at <https://imexio.ndml.in/>.

Important features of the IMEXIO includes:

- Registration by CHAs & addition of multiple clients (both DTA/EDI & SEZ)
- Registration by DTA companies

- Registration by SEZ Units / Developers / Co-developers
- Single registration for document preparation through multiple ports
- Preparation of BOE (Import) & DTA Sale BOE transactions (Both manufacturing & Trading transactions)
  - o Digitally signed files for upload on ICEGATE portal
  - o Status recording of ICEGATE processing against BOE uploaded through IMEXIO
  - o Preparation of BOE with Excel Upload
  - o Document signer for upload on e-Sanchit
